



PARTICIPANT RELEASE

PLEASE READ CAREFULLY. SIGN AND RETURN TO NIKE

Amateur/High School/College Eligibility: I understand and agree that if I am, or may become, an amateur or student athlete, I am responsible for my own high school/college eligibility and/or amateur standing. I am aware of, and agree to comply with, all rules, regulations, and bylaws of my state/territory/national association(s) responsible for administering or regulating interscholastic or amateur athletics, the NCAA and of any other governing bodies that may be applicable to me (the "Rules"). In consideration for being allowed to participate in the "Area Code Baseball Games" ("Event") at "Blair Field 4700 Deukmejian Dr, Long Beach, CA 90804" on "July 31-August 10, 2026", organized or sponsored by Nike, Inc. ("NIKE"), its affiliates, and related parties, including all associated activities (such as transportation, lodging, and product experiences), I acknowledge and agree to the following:

1. ASSUMPTION OF RISK. Participation in or attendance at the Event involves inherent risks and dangers of accidents, personal and bodily injury (including death), and property loss or damage, as well as severe social and economic losses. These may result from my own actions or inactions, as well as the actions or inactions of others, the rules of play, consumption of food or drink, and the condition of the facilities, equipment, or vehicles. Further, there may be other risks not known to me and not reasonably foreseeable at this time. I have considered the nature and extent of the risks involved, and I voluntarily choose to assume all such risks, both known and unknown, even those risks that result from the negligence of the Released Parties (defined below) or others, and I assume full responsibility for my participation in the Event. I acknowledge that NIKE has not arranged for nor carries any insurance of any kind for my benefit. I consent to treatment in the event of an emergency or other incident in which, in the reasonable judgment of the on-site personnel, I require medical care. I further agree to pay all costs associated with such medical care and to indemnify and hold harmless the Released Parties (as defined below) from any costs or claims arising from such medical care.

2. RELEASE FROM LIABILITY. I, on behalf of myself and my heirs, estate, insurers, successors, and assigns, fully release and discharge NIKE, its affiliates, subsidiaries, officers, directors, shareholders, employees, agents, distributors, representatives, contractors, successors, assigns, and insurers, all Event sponsors, advertisers, volunteers, and staff, and all owners or lessors of premises used in connection with the Event ("Released Parties") from any and all liability—including injuries, death, losses, damages, claims (including negligence), demands, lawsuits, expenses, or other liabilities—arising directly or indirectly from my participation in the Event, even if caused by the Released Parties' negligence, to the fullest extent allowed by law. I UNDERSTAND AND AGREE THIS RELEASE PREVENTS ME AND MY SUCCESSORS FROM BRINGING ANY LEGAL ACTION OR SEEKING DAMAGES FROM THE RELEASED PARTIES REGARDING THE ABOVE CLAIMS. THE RELEASED PARTIES DO NOT WARRANT THAT THE EVENT OR EVENT-RELATED SERVICES (INCLUDING PRODUCT GIVEAWAYS) WILL BE SECURE OR ERROR-FREE AND EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT.

3. PARENT/GUARDIANS. If I am signing this Participant Release on behalf of a minor, then I am representing that I know the minor's experience and capabilities and believe the minor is qualified to participate in the Event. If at any time I believe conditions surrounding the activity or the minor's participation are unsafe, I will immediately discontinue the minor's participation in the Event. I further understand and agree that acceptance of the terms and conditions are on behalf of a minor child.

4. AUTHORIZATION TO RECORD AND TO USE RECORDINGS AND NAME AND LIKENESS. I hereby grant to NIKE, its affiliates, subsidiaries, successors, assigns, licensees, distributors (including retail partners), contractors, and Event sponsors (collectively, the "Authorized Parties") permission to film, photograph, video record and otherwise record my image, voice, quotes, avatar, name, likeness, biographical data, silhouette, body dimension, shape, posture, personal property, musical content, artistic performances, or any other aspect of my attendance at the Event (collectively, the "Recording") and the right, throughout the world, in perpetuity, to register for copyright, to use and to assign and/or license others to use all or any portion of the results thereof (or a reproduction thereof), in all media and in any manner now known or hereafter developed, in connection with the Event, or otherwise without any additional consideration. I shall have no right of approval and no legal claim arising out of any use or editing of the Recording or my name. The Authorized Parties shall have no obligation to use any of the rights I grant. I represent that it is not necessary for the Authorized Parties to obtain permission from or to pay any third party in connection with the rights granted in this paragraph.

5. AUTHORIZATION TO COLLECT AND USE DATA. While engaging in the Event, you may provide to the Authorized Parties (1) information such as your name, contact information, age, gender, and other demographic, physical, physiological or identifying characteristics specifically requested from you; and (2) data regarding your use or interaction with NIKE products or services including any feedback, comments or ideas you provide about the product, testing, or your experience (collectively "Event Data"). Your participation in the Event is voluntary. By participating in the Event and providing the Event Data to the Authorized Parties, you hereby grant the Authorized Parties permission to collect, capture, record, and store the Event Data, and grant to the Authorized Parties a license to use the Event Data for any purposes whatsoever, including, but not limited to, developing, manufacturing and marketing products and services and creating, modifying or improving products and services.

6. ARBITRATION. In the event of any dispute between me and any of the Released Parties, such dispute shall be settled by arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules (but not its Procedures for Large, Complex Commercial Disputes). The hearing shall be conducted in Portland, Oregon unless both parties consent to a different location. The decision of the arbitrator shall be final and binding upon all parties, and judgment upon the award rendered pursuant to such arbitration may be entered in any court of competent jurisdiction.

7. CONFIDENTIALITY. I understand that, during the Event, I may be exposed to ideas, designs, discoveries, inventions, and trade secrets, including footwear, apparel and equipment designs under development, fabrication processes, innovative materials, drawings, business and marketing plans, sales data, and research about biomechanics and exercise physiology. I agree that all of NIKE's files, data, and information are and shall remain the property of NIKE and as such may not be used, or copied or distributed to third parties, without the express prior written consent of NIKE. My obligations of non-disclosure with respect to NIKE's proprietary information shall remain in effect for five years from the date I gain access, so long as such information has not entered into the public domain.

I represent that I have read this Participant Release, fully understand it, and agree to its terms, and I understand and acknowledge that I am giving up substantial rights by accepting the terms of this Participant Release. I sign this Participant Release freely and voluntarily, without any inducement or coercion.
